<p><b>CONDITIONS FOR REDUCED RENTAL RATE PLAN</b></p> <ul style="list-style-type: none"> <li>- Groups must book for entire school year – September to June</li> <li>- Minimum 2 hour rental per week</li> <li>- No refunds for cancelled bookings unless the cancellations exceed 25% of the annual booking</li> <li>- All other fees apply</li> </ul>	25% Reduced Rental Fee

<u>CUSTODIAL FEES</u>	<i>(RATES ARE SUBJECT TO CHANGE)</i>
<p><b>REGULAR CUSTODIAL FEE</b> Applies when the school custodian is not on site - Weekends, Spring Break, Summer, Winter Break, Non-Instructional Days, etc. A custodial fee may also apply for larger groups, even when the school custodian is on site.</p>	\$31.00/hr. - Minimum 4 hour call-out
<p><b>**SMALL GROUP CUSTODIAL FEE (Conditions Apply)</b> The custodial fee may be waived for groups with less than 20 participants booking for 2 hours during times when the school custodian is not on site. In lieu of the <i>Regular Custodial Fee</i>, the rental fee will be increased by 25% to offset the cost of cleaning.</p>	- Regular Custodial Fee Waived - 25% Increase to Rental Fee

<u>OTHER FEES</u>	<i>(RATES ARE SUBJECT TO CHANGE)</i>
<p><b>ADMINISTRATION FEE (Non-Refundable)</b>  <i>*Applies to ALL rental groups –one fee per location</i>  <i>*Payment must be attached to each rental application.</i></p>	\$15.00
<p><b>DELIVERY FEE – OUT OF TOWN</b>  <i>*Fee charged for the delivery of tables, chairs, etc to school locations. A rental fee for the use of tables &amp; chairs will also apply.</i></p>	\$160.00
<p><b>RENTAL FEE – TABLES</b>  <i>*Fee charged to SD No. 73 user groups for the use of tables.</i>  <i>*Rental of tables to SD 73 sites only</i></p>	\$5.00/table
<p><b>RENTAL FEE – CHAIRS</b>  <i>*Fee to SD No. 73 user groups. Applies when more than 30 chairs are requested.</i>  <i>*Rental of chairs to SD 73 sites only</i></p>	\$0.25/chair

# USER GROUP CLASSIFICATION DEFINITIONS

## NON-PROFIT (General)

User groups receive the Non-Profit (General) rental rate classification if they meet the following criterion:

- The user group is incorporated as a Non-Profit Organization

## NON-PROFIT (Youth)

User groups receive the Non-Profit (Youth) rental rate classification if they meet the criterion for Non-Profit (General), in addition to the following criterion:

- The user group's primary purpose (as documented in their Articles of Incorporation) is to serve the interests of children & youth

## COMMERCIAL & PROFIT (General)

User groups receive the Commercial & Profit (General) rental rate classification if they meet the following criterion:

- The user group is an incorporated or unincorporated business where the shareholders or sole proprietor have a chance of profit or risk of loss from its business operations

## COMMERCIAL & PROFIT (Small Business)

User groups receive the Commercial & Profit (Small Business) rental rate classification if they meet the criterion for Commercial & Profit (General), in addition to any of the following criteria:

- The user group is an unincorporated business where the sole proprietor is charging the group members a fee to participate in an activity that is led by the sole proprietor in the space rented OR
- The user group is an incorporated business where the shareholder is charging the group members a fee to participate in an activity that is led by the shareholder in the space rented
