The undersigned legal guardian(s) or parents(s) of the above referenced student hereby confirm my request that my son/daughter be released from the Kamloops ISP. I acknowledge and fully understand that upon my son/daughter's termination from the Kamloops ISP, the District will have no further responsibility for the safety and welfare of my son/daughter. I also understand and agree that upon termination of my son/daughter from the Kamloops ISP:



1. That the District and Kamloops ISP will no longer sponsor my son/daughter as an ISP participant and has an obligation to report his/her termination from the program to all appropriate government agencies, including but not limited to, Immigration and other regulatory departments. Such reporting usually results in withdrawal of the student's host country resident visa.
2. That the District and Kamloops ISP will no longer arrange for a host family or provide a homestay program, or any other accommodation, support or supervision services for my son/daughter, and will have no further involvement whatsoever in the activities of my son/daughter. From the date my son/daughter is released from the ISP program, it will be solely my responsibility to arrange for accommodation, support and supervision, and ensure the general welfare, safety and care of my son/daughter.
3. I will on my own behalf, and to the fullest extent legally possible on behalf of my son/daughter, release the District and the Kamloops ISP and its officers, representatives, employees, agents, directors, host families, managers and insurers from any and all liability, claims, costs, expenses, charges, suits, actions and demands, including settlements of the foregoing (collectively, the "Liabilities") for property damage or personal injuries, including death, which may be suffered by me or my son/daughter, arising in connection with or as a result of the District and the Kamloops ISP releasing my son/daughter from the Kamloops ISP, but my son/daughter remaining in Canada for purposes other than attendance of the Kamloops ISP.
4. I will indemnify and hold harmless the District, its officers, representatives, employees, agents, directors, host families, managers and insurers from any and all of the Liabilities (including any claims brought on behalf of my son/daughter to the extent that the above release is not enforceable) arising in connection with or as a result of the District and the Kamloops ISP releasing my son/daughter from the Kamloops ISP, but my son/daughter remaining in Canada for purposes other than attendance of the Kamloops ISP.
