



CONSENT, RELEASE OF LIABILITY AND INDEMNITY

FOR TRAVEL OUTSIDE OF KAMLOOPS-THOMPSON SCHOOL DISTRICT WITH THEIR HOMESTAY FAMILY

The Board of Education of School District No. 73 (Kamloops) ("School District") facilitates student international programs (the "Program") by coordinating accommodations for eligible international students (each a "Student") with homestay families in Canada (each a "Homestay Family"). The Homestay Family has primary responsibility for the care and supervision of Students while at a Homestay Family's residence ("Homestay Residence"), including when arranging outings, travel and other activities for Students. The School District does not supervise activities that take place at a Homestay Residence or during outings arranged by the Homestay Family.

The purpose of this Consent, Release of Liability and Indemnity is to obtain the informed consent of Students and Parents for participation in the following travel which has been arranged by or through the Homestay Family (the "**Activity**").

By signing this Consent, Release of Liability and Indemnity you acknowledge, understand and agree that:

1. I have read and understand this Consent Form, and understand that the Student's participation in the Activity and related travel carries certain risks, including the risk of property loss or damage and injury, illness and even death.
2. The School District will not be supervising the Student while he or she is participating in the Activity.
3. During the Activity, the Student may be permitted to participate in activities or events in the community alone or with peers that are not supervised by an adult.
4. The School District and the Homestay Family may collect, use, share and disclose personal information about the Student and the Parent for the purposes of facilitating and administering the Student's participation in the Activity.



5. If necessary during the Activity, the Parent and the Student authorizes the Homestay Family to administer first aid treatment for minor injuries or illnesses, and if the injury or illness is severe to seek professional emergency or medical personnel to attend, transport and treat the Student.
6. To the fullest extent permitted by law, the Parent RELEASES AND FOREVER DISCHARGES the School District and the Homestay Family, and their respective trustees, directors, officers, servants, agents, employees, heirs, executors, administrators, successors and assigns (collectively, the "Protected Parties"), from any costs, expenses or liabilities of any kind, arising from any and all claims, actions, causes of action and demands which the Parent or or the Student can, shall or may have for any personal injury, death, damage to property, or any other damage or loss (including if arising from claims of negligence by the School District or Homestay Family), which hereafter may be sustained by the Parent or Student in consequences of, or arising out of, the Student participating in the Activity.
7. To any extent that the Parent may not have legal authority to provide this release of liability on behalf of the Student, then the Parent shall indemnify and hold harmless the Protected Parties from any claims, actions, causes of action and demands which are threatened or made on behalf of the Student against the Protected Parties, for all costs and expenses whatsoever including lawyer fees on a solicitor-client basis, and any consequential damages.
8. The consideration for this release and indemnity is that the School District and Homestay Family is permitting the Student to participate in the Activity. The Parent acknowledges that without such release and indemnity, the Student would not be permitted to participate.

I/WE HEREBY PROVIDE MY/OUR CONSENT for the Student to participate in the Activity.

I/we have **READ AND UNDERSTAND** this **Consent, Release of Liability and Indemnity** and hereby confirm that this release is signed voluntarily and that I/we have had an opportunity to obtain independent legal advice concerning its terms.
